TOP 5 BSSE MEMBERS IN 4th QUARTER OF THE YEAR 2022

In the 4th quarter of 2022, the total turnover of transactions on BSSE amounted to 170.160 million EUR, (by 6.57 % less than in the same period last year). A total 2,422 of transactions were closed in the said period, including 260 share transactions and 2,162 bond transactions. The turnover of share transactions amounted to 2.600 million EUR (1.53 % of the total turnover), whereas the turnover of bond transactions amounted to 167.560 million EUR (98.47 % of the total turnover).

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 4th quarter of 2022 as divided by shares, bonds and total turnover.
