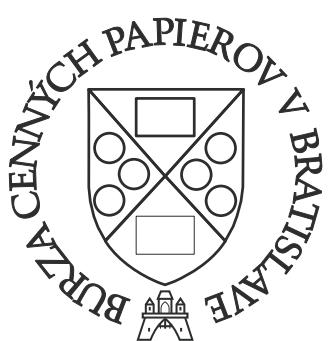

INTRODUCTION

SECURITIES ON STOCK EXCHANGE MARKETS

As of the end of the year 2009, Bratislava Stock Exchange (BSSE) had 269 issues of securities (shares and bonds) placed on its markets. That includes 28 issues placed on the main listed market, 105 issues on the parallel listed market and 136 issues on the regulated free market.

Issues admitted in the year 2009

In the course of the year 2009, the BSSE started to trade a total of 36 new issues of securities of local issuers. Out of that, only 5 were share issues. While only 2 government-bond issues and 2 issues of state treasury bills were admitted to the main listed market in the year 2009, the parallel listed market was joined by 17 new issues of securities (including 11 issues of mortgage bonds, 4 share issues and 2 issues of bank bonds). Fifteen new issues of securities (including 8 issues of mortgage bonds, 4 issues of bank bonds, 2 issues of corporate bonds and 1 share issue) were registered on the regulated free market.

In addition to the newly admitted bond issues, the influx of new capital to the BSSE markets continued through admission of new tranches of the already admitted government bonds. The issued volume of 5 government-bond issues was increased in this manner in the course of the year 2009, in a total nominal value of EUR 3.62 billion. The total value of the capital newly admitted to the BSSE markets thus amounted to EUR 8.59 billion.

Issues that ended trading in the year 2009

In the twelve months of the year 2009, the BSSE ended trading (upon the issuer's request) of 11 share issues and 43 issues of share certificates on the regulated free market. The total nominal value of said issues is EUR 111.23 million. The BSSE also excluded from trading on the regulated free market 6 share issues of 6 issuers, in a total nominal volume of EUR 21.72 million, due to the issuers' failure to comply with their legal information duties for the year 2008 or, respectively, for the first half-year 2009. Due to cancellation of issues in the CDCP, the BSSE ended trading of 3 share issues in a total nominal amount of EUR 77.64 million. In the course of the year 2009, trading of 3 share issues in a total nominal amount of EUR 367.14 million was ended on the regulated free market. These issues, however, were subsequently admitted to the parallel listed market.

Due to maturity, the BSSE ended trading of 27 bond issues in a total nominal value of EUR 4.73 billion, and 1 bond issue in a nominal value of BGN 30 million on the market of listed securities (2 issues of government bonds, 1 issue of state treasury bills, 21 issues of mortgage bonds, 3 issues of bank bonds and 1 issue of corporate bonds). Trading of 3 issues of corporate bonds, in a volume of EUR 6.04 million, was ended on the regulated free market due to their redemption.

TRADING

In the year 2009, the BSSE's electronic trading system was open to members in 249 business days. A total of 3 626 transactions were concluded in this period, in which 3 064 622 121 units of securities were traded and the financial volume amounted to EUR 11.79 billion. In comparison with the trading results of the year 2008, it represents a 51.55-percent decrease of the financial volume, with a 52 722.38-percent increase of the amount of traded securities

and an 18.06-percent decrease of the number of transactions. The dramatic increase is a result of transactions in government bonds and state treasury bills, which have a nominal value of 1 EUR. Similar to previous years, the year 2009 saw negotiated deals dominate over electronic order book transactions, with the former achieving as much as a 94.02-percent share in the total trading volume in the period under review. So the situation repeated itself, as 1 724 electronic order book transactions in a financial volume of EUR 705.11 million (+93.44% on a year-on-year basis) simply could not compete with 1 902 negotiated deals in a volume of EUR 11.09 billion (-53.76% year on year).

In the year 2009, investors trading on the BSSE continued to prefer debt securities over equity securities. Bond transactions generated as much as 98.97% of the total financial volume. In 249 business days of the year 2009, the volume of transactions in debt securities climbed to EUR 11.67 billion EUR (-52.02% in a year-on-year comparison), generated in most part by negotiated deals. Equity securities continued to lag behind, as the volume of traded equity securities only totalled EUR 121.75 million (+704.53% in a year-on-year comparison). Trading of shares was also dominated by negotiated deals, as was the case with bonds.

The financial volume of REPO transactions (including retransfers) in the year 2009 totalled EUR 34 592.48, representing a 67.28-percent decrease in comparison with the year 2008. Only one REPO transaction was concluded in total, in which only equity securities were traded.

Transactions concluded by non-residents in the year 2009 accounted for 53.33% of the total trading volume, out of which the buy side represented 48.84% and the sell side 57.81%. Natural persons achieved a 0.17-percent share in the total volume; the remaining part belonged to legal entities.

Trading of shares

As of the last trading day of the year 2009, transactions on the BSSE could be concluded in 133 share issues (of 107 issuers). Out of that, 5 share issues were placed on the main listed market, 11 share issues on the parallel listed market and 117 issues on the regulated free market.

As of the year-end 2009, the market capitalisation of equity securities traded on the BSSE markets recorded an 8.54-percent decline on a year-on-year basis to EUR 3.55 billion. The real market capitalisation, that is the market capitalisation comprising issues that have historically at least one market price (excluding share certificates), totalled EUR 3.26 billion (-10.87% on a year-on-year basis) and represented 91.75% of the share market's total market capitalisation. The market capitalisation of share issues placed on the market of listed securities has risen, since the end of the previous year, by 3.82% to EUR 2.41 billion.

The year of 2009 was characterised by continuing lack of investor interest in equity securities. The annual trading volume of share transactions – EUR 121.75 million (including obligatory public offers to take over) - only accounted for 1.03% of the total trading volume. In 12 months of the year 2009, the shares of local companies were bought and sold in 1 837 transactions, in which 8 876 113 share units were traded. In comparison with the year 2008, it represents a 704.53-percent increase of the trading volume, with a 13.51-percent decrease of the amount of concluded transactions and a 3 775.95-percent increase of the number of traded securities. When trading equity securities, investors again preferred negotiated deals and thus over 97.57% of the volume of share transactions were generated in 447 negotiated deals. The remaining part of the traded volume (EUR 2.95 million) was generated in 1 390 electronic order book transactions. On a year-on-year basis it represents a 976.34-percent increase of volume achieved in negotiated deals, and a 27.9-percent decrease of financial volume from electronic order book transactions.

From a perspective of achieved financial volume, the year 2009's most frequently traded share issues on the market of listed securities were Best Hotel Properties (EUR 75.7 million; 14 transactions), Tatry mountain resorts 6 (EUR 30 million; 2 transactions) and

Všeobecná úverová banka (EUR 4.35 million; 247 transactions). Setting apart the public offers to take over, the BSSE's regulated free market was in 2009 dominated by the share issue Tatry mountain resorts (EUR 4.3 million; 10 transactions), followed by Tatra banka (EUR 1.16 million; 41 transactions) and Best Hotel Properties (EUR 80 000; 4 transactions). With a 62.2-percent share, the share issue of Best Hotel Properties substantially contributed to the total financial volume achieved.

Five new obligatory public offers to take over were announced on the BSSE in the year 2009. On the other hand, 6 public offers to take over expired in the same period, including one that had been announced back in the year 2008. The financial volume of transactions generated in the realised public offers to take over exceeded EUR 749 049, in 115 transactions. The volume of transactions concluded in public offers to take over represents 0.62% of the total volume of share transactions. Out of all transactions in equity securities, over 6.26% were concluded within the framework of these public offers.

Transactions concluded by non-residents in 2009 accounted for 90.33% of the total volume of share transactions, out of which the buy side represented 90.22% and the sell side 90.45%.

Trading of bonds

As of the last trading day of the year 2009, transactions on the BSSE could be concluded in 136 bond issues (83 issues of mortgage bonds, 20 issues of government bonds, 18 issues of corporate bonds, 12 issues of bank bonds, 2 issues of state treasury bills and 1 Eurobond). Out of that, 23 issues were placed on the main listed market, 94 issues on the parallel listed market (including 2 issues denominated in CzK) and 19 issues on the regulated free market.

As of the year-end 2009, the market capitalisation of debt securities admitted to the BSSE markets amounted to EUR 20.24 billion. In comparison with the year 2008, it represents an increase by 21.11%. The market capitalisation of bonds traded on the market of listed securities has increased, since the end of December 2008, by 21.12% to EUR 19.52 billion. The capitalisation of bond issues denominated in CzK, which are traded on the parallel listed market, amounted to EUR 67.99 million.

Similar to previous periods, investors in 2009 opted to put their financial means into debt securities rather than share issues. This was reflected mainly in the trading volume structure, where bond transactions generated as much as 98.97% of the total financial volume. This percentage only confirms the fact that the Slovak capital market is primarily a market of debt securities. A total of 1 789 transactions were concluded in the period under review, in which 3 055 746 008 units of debt securities were traded in a financial volume of EUR 11.67 billion. The year 2009 thus lags far behind the year 2008. Notwithstanding a significant increase in the amount of traded bonds (+54 733.78%), thanks to government bonds and state treasury bills with a nominal value of 1 EUR, the financial volume fell more than 52%. Trading of debt securities was also dominated by negotiated deals (in a volume of EUR 10.97 billion), which significantly surpassed electronic order book transactions (in a volume of EUR 702.16 million). Similar to previous years, the most substantial amounts of money were invested in government bonds and state treasury bills. These transactions totalled EUR 11.37 billion (in 1 479 transactions), and represented 97.37% of the total volume of bond transactions.

From a viewpoint of achieved financial volume, the following were among the most frequently traded issues of the public sector in the period under review: government bonds of series 208 (EUR 2.51 billion; 134 transactions), government bonds of series 210 (EUR 1.55 billion; 37 transactions) and government bonds of series 211 (EUR 1.4 billion; 219 transactions). The following issues of debt securities were most frequently traded in the private sector: mortgage bonds VÚB XVII (EUR 30 million; 6 transactions), mortgage bonds SPO 12 (EUR 28.04 million; 5 transactions) and bonds VÚB X (EUR 27.49 million; 6 transactions). The government-bond issue of series 202 recorded the highest number of transactions in the year 2009 (246). In terms of electronic order book transactions, the most noticeable issue in the public sector was an issue of state treasury bills ŠPP 01, with a volume of EUR 133.21 million. In the private

sector, it was a mortgage-bond issue VÚB XVII (EUR 27.27 million).

Transactions concluded by non-residents in the year 2009 accounted for 52.94% of the total volume of bond transactions, out of which the buy side represented 48.41% and the sell side 57.47%.

On the last trading day of the year 2009, transactions in the module of market makers (MTT) could be concluded in 7 government-bond issues of series 174, 188, 189, 199, 202, 204 and 205. The volume of transactions in said issues, concluded in the MTT, totalled EUR 6.35 million in 9 transactions. It represents a 0.9-percent share in all electronic order book transactions in bonds.

INDICES

The SAX index ended the year 2009 at 266.97 points, weakening against the end of the previous year by 25.67%. The following are year-on-year changes of the SAX index base issues in the year 2009: Biotika (-32.59%; EUR 8.50), OTP Banka Slovensko (-6.63%; EUR 9.30), SES Tlmače (-36.16%; EUR 18.01), Slovnaft (-30.06%; EUR 65.00), VÚB (-30.15%; EUR 64.00).

At a meeting held on 26 January 2009, the Commission for the SAX Index decided to leave the currently valid base of the SAX index unchanged. On 30 January 2009, the Commission again corrected the weights of the base issues in order for the weight of one company to not exceed a 30-percent limit. The Commission also set the correction coefficients of all base issues to the same value, that is 0.209966. Dividends of the following companies were paid out by the year-end 2009 and factored in the index: SLOVNAFT (EUR 3.19; date of record: 24 April 2009).

The group of the Slovak bond indices – the SDXGroup - ended the year 2009 with the following values: The SDXGroup for the public sector, represented by government bonds, closed at 107.012 (price) and 137.951 (performance), with a yield to maturity of 3.844% and duration of 5.02 years. The SDXGroup for the private sector, now only represented by mortgage bonds, ended the year 2009 at 98.85 (price) and 136.015 (performance) with a yield to maturity of 4.691% and duration of 2.987 years.

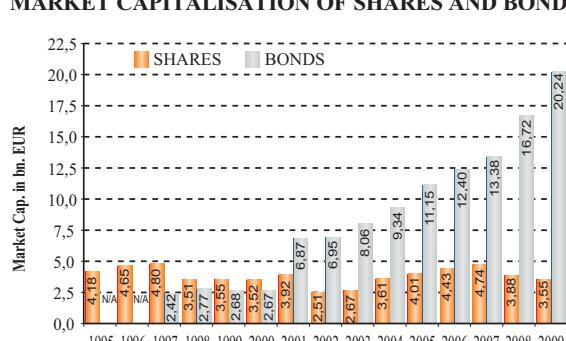

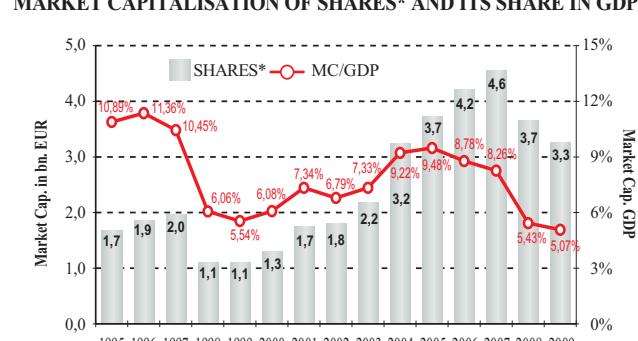

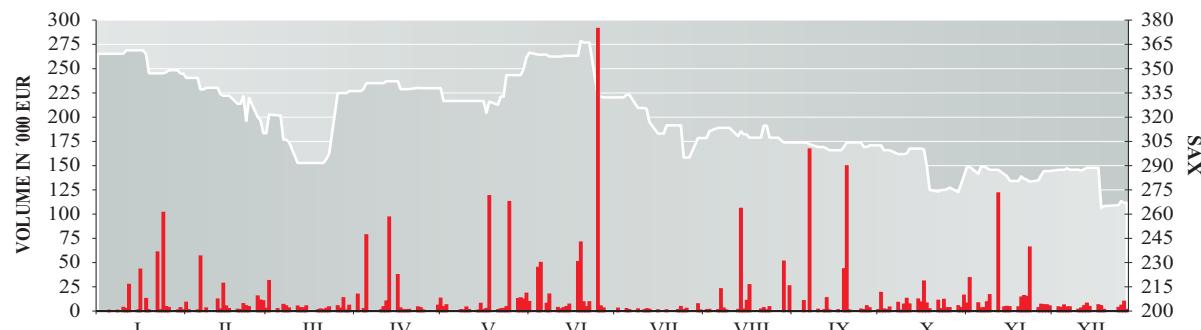

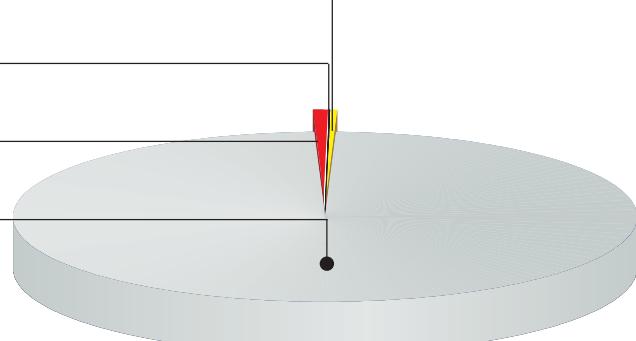

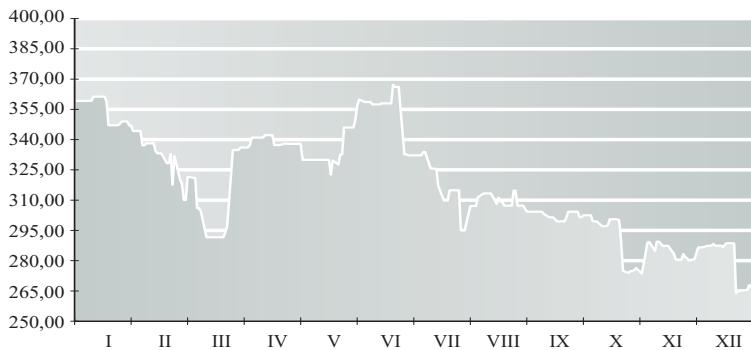

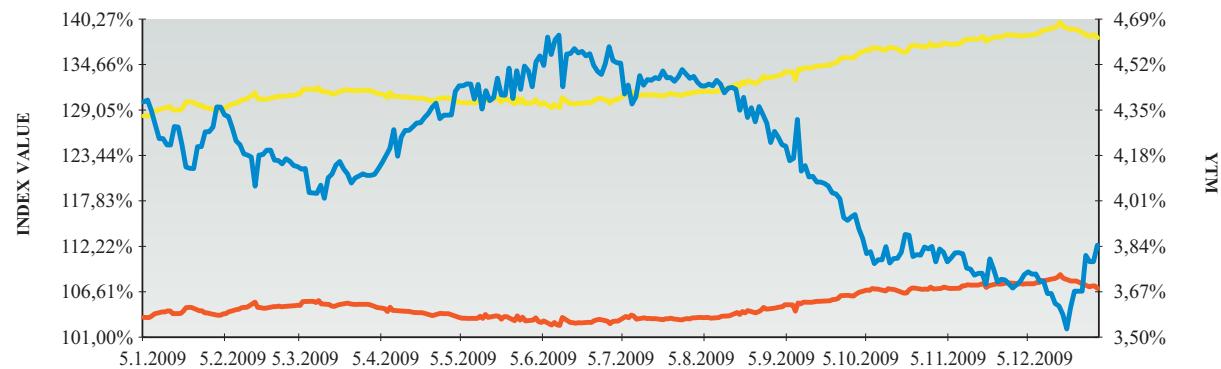

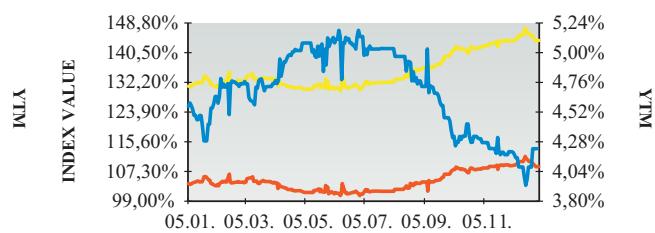

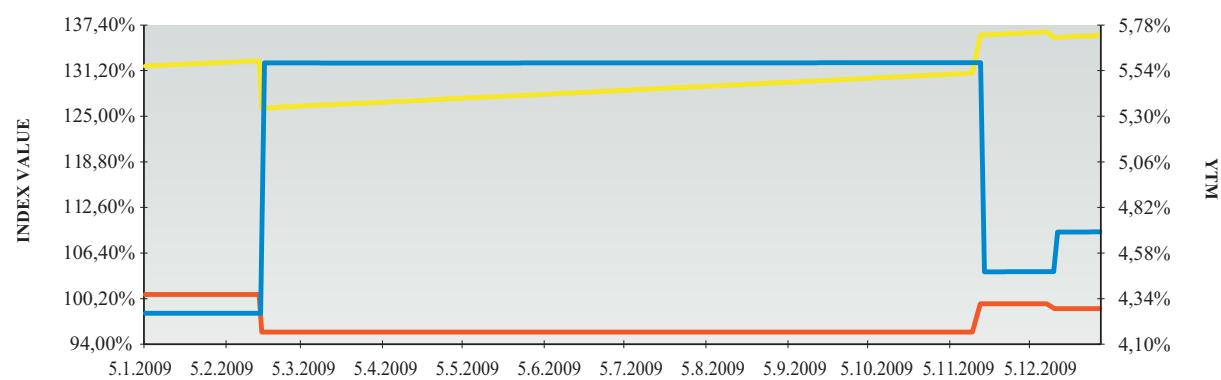

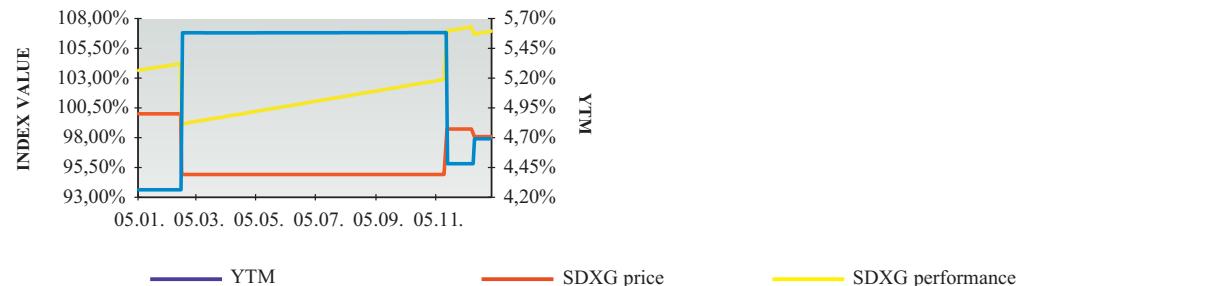

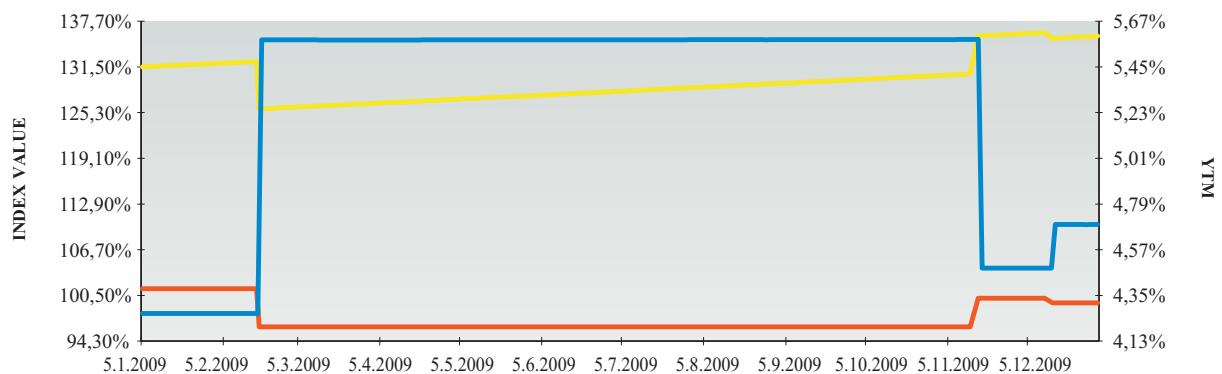

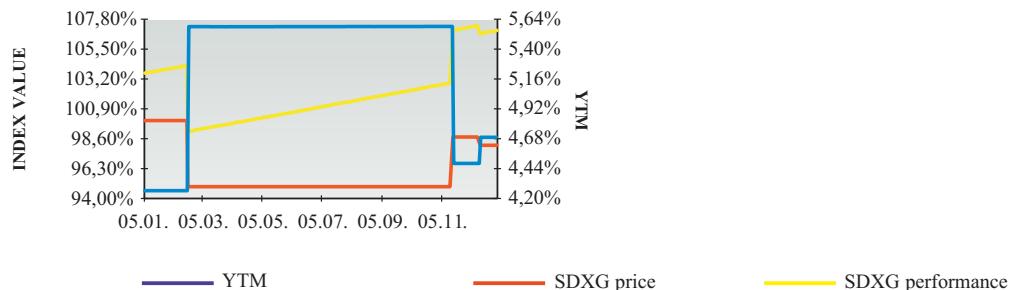


DEVELOPMENT OF SDXGROUP INDICES (SLOVAK BOND INDICES GROUP) IN 2009 BY SUBSECTORS
