TOP 5 BSSE Members in the 1st Quarter of the Year 2023

In the 1st quarter of 2023, the total turnover of transactions on BSSE amounted to 144.466 million EUR, (by 32.47 % more than in the same period last year). A total 1,664 of transactions were closed in the said period, including 243 share transactions and 1,421 bond transactions. The turnover of share transactions amounted to 2.909 million EUR (2.01 % of the total turnover), whereas the turnover of bond transactions amounted to 141.557 million EUR (97.99 % of the total turnover).

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the first quarter of 2023 as divided by shares, bonds and total turnover.
