TOP 5 BSSE Members in the 1st Half-Year of the Year 2023

In the 1st half-year of 2023, the total turnover of transactions on BSSE amounted to 262.050 million EUR, (by 13.74 % less than in the same period last year). A total 6,258 of transactions were closed in the said period, including 742 share transactions and 5,516 bond transactions. The turnover of share transactions amounted to 3.683 million EUR (1.41 % of the total turnover), whereas the turnover of bond transactions amounted to 258.367 million EUR (98.59 % of the total turnover).

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 1st half-year of 2023 as divided by shares, bonds and total turnover.
