TOP 5 BSSE MEMBERS IN 3rd QUARTER OF THE YEAR 2023

In the 3rd quarter of 2023, the total turnover of transactions on BSSE amounted to 148.282 million EUR, (by 7.56 % less than in the same period last year). A total 2,033 of transactions were closed in the said period, including 97 share transactions and 1,936 bond transactions. The turnover of share transactions amounted to 1.066 million EUR (0.72 % of the total turnover), whereas the turnover of bond transactions amounted to 147.219 million EUR (99.28 % of the total turnover).

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 3rd quarter of 2023 as divided by shares, bonds and total turnover.
