TOP 5 BSSE MEMBERS IN 4th QUARTER OF THE YEAR 2023

In the 4th quarter of 2023, the total turnover of transactions on BSSE amounted to 229.863 million EUR, (by 35.09 % more than in the same period last year). A total 2,140 of transactions were closed in the said period, including 146 share transactions and 1,994 bond transactions. The turnover of share transactions amounted to 0.957 million EUR (0.42 % of the total turnover), whereas the turnover of bond transactions amounted to 228.906 million EUR (98.58 % of the total turnover).

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 4th quarter of 2023 as divided by shares, bonds and total turnover.
