TOP 5 BSSE MEMBERS IN 1st QUARTER OF THE YEAR 2024

In the 1st quarter of 2024, the total turnover of transactions on BSSE amounted to 149.678 million EUR, (by 3.61 % more than in the same period last year). A total 1,858 of transactions were closed in the said period, including 257 share transactions and 1,601 bond transactions. The turnover of share transactions amounted to 1.238 million EUR (0.83 % of the total turnover), whereas the turnover of bond transactions amounted to 148.440 million EUR (99.17 % of the total turnover).

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 1st quarter of 2024 as divided by shares, bonds and total turnover.
