TOP 5 Members in the 2nd Quarter of the Year 2024

In the 2nd quarter of 2024, the total turnover of transactions on BSSE amounted to 285.06 million EUR, (by 142.43 % more than in the same period last year). A total 6,110 of transactions were closed in the said period, including 436 share transactions and 5,674 bond transactions. The turnover of share transactions amounted to 2.73 million EUR (0.94 % of the total turnover), whereas the turnover of bond transactions amounted to 282.34 million EUR (99.06 % of the total turnover).

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the second quarter of 2024 as divided by shares, bonds and total turnover.
