TOP 5 BSSE MEMBERS IN 3rd QUARTER OF THE YEAR 2024

In the 3rd quarter of 2024, the total turnover of transactions on BSSE amounted to 209.280 million EUR, (by 29.15 % more than in the same period last year). A total 1,630 of transactions were closed in the said period, including 147 share transactions and 1,483 bond transactions. The turnover of share transactions amounted to 1.186 million EUR (0.57 % of the total turnover), whereas the turnover of bond transactions amounted to 208.094 million EUR (99.43 % of the total turnover).

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 3rd quarter of 2024 as divided by shares, bonds and total turnover.
