TOP 5 BSSE MEMBERS IN 2nd QUARTER OF THE YEAR 2025

In the 2nd quarter of 2025, the total turnover of transactions on BSSE amounted to 144.97 million EUR, (by 49.15 % less than in the same period last year). A total 3.664 of transactions were closed in the said period, including 284 share transactions and 3.380 bond transactions. The turnover of share transactions amounted to 1.24 million EUR (0.85 % of the total turnover), whereas the turnover of bond transactions amounted to 143.73 million EUR (99.15 % of the total turnover).

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 2nd quarter of 2025 as divided by shares, bonds and total turnover.
