TOP 5 BSSE Members in the 1st Half-Year of the Year 2025

In the 1st half-year of 2025, the total turnover of transactions on BSSE amounted to 288.84 million EUR, (by 33.56 % less than in the same period last year). A total 7,204 of transactions were closed in the said period, including 606 share transactions and 6,598 bond transactions. The turnover of share transactions amounted to 3.16 million EUR (1.10 % of the total turnover), whereas the turnover of bond transactions amounted to 285.68 million EUR (98.90 % of the total turnover).

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 1st half-year of 2025 as divided by shares, bonds and total turnover.
