TOP 5 BSSE MEMBERS IN 1st QUARTER OF THE YEAR 2025

In the 1st quarter of 2025, the total turnover of transactions on BSSE amounted to 143.87 million EUR (by 3.88% less than in the same period last year). A total of 3.540 transactions were closed in the said period, including 322 share transactions and 3.218 bond transactions. The turnover of share transactions amounted to 1.93 million EUR (1.34% of the total turnover), whereas the turnover of bond transactions amounted to 141.95 million EUR (98.66% of the total turnover).

The following tables show the sequence of the top 5 members according to their turnovers achieved in the 1st quarter of 2025 as divided by shares, bonds and total turnover.
