TOP 5 BSSE MEMBERS IN 3rd QUARTER OF THE YEAR 2025

In the 3rd quarter of 2025, the total turnover of transactions on BSSE amounted to 306.300 million EUR, (by 46.36% more than in the same period last year). A total 6,742 of transactions were closed in the said period. The turnover of share transactions amounted to 1.792 million EUR (0.59 % of the total turnover) in 382 transactions, whereas the turnover of bond transactions amounted to 304.508 million EUR (99.41% of the total turnover) in 6,360 transactions.

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 3rd quarter of 2025 as divided by shares, bonds and total turnover.
