**TOP 5 BSSE MEMBERS IN 4th QUARTER OF THE YEAR 2025**

In the 4th quarter of 2025, the total turnover of transactions on BSSE amounted to 258.11 million EUR (by 14.76% more than in the same period last year) in 3,086 transactions. The turnover of share transactions amounted to 1.62 million EUR (0.63% of the total turnover) in 239 transactions, whereas the turnover of bond transactions amounted to 256.49 million EUR (99.37% of the total turnover) in 2,847 transactions.

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 4th quarter of 2025 as divided by shares, bonds and total turnover.
