**TOP 5 BSSE MEMBERS IN 2025**

In 2025, the total turnover of transactions on BSSE amounted to 853.25 million EUR (by 1.81% less than in 2024) in 10,059 transactions. The turnover of share transactions amounted to 6.58 million EUR (0.77% of the total turnover) in 733 transactions, whereas the turnover of bond transactions amounted to 846.68 million EUR (99.23% of the total turnover) in 9,326 transactions.

The following tables shows the sequence of the top 5 members according to their turnovers achieved in 2025 as divided by shares, bonds and total turnover.
