TOP 5 BSSE MEMBERS IN 1st QUARTER OF THE YEAR 2026

In the 1st quarter of 2026, the total turnover of transactions on BSSE amounted to 178.639 million EUR, (by 24.16% more than in the same period last year). A total 4,994 of transactions were closed in the said period. The turnover of share transactions amounted to 1.017 million EUR (0.57 % of the total turnover) in 560 transactions, whereas the turnover of bond transactions amounted to 177.622 million EUR (99.43% of the total turnover) in 4,434 transactions.

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 1st quarter of 2026 as divided by shares, bonds and total turnover.
