TOP 5 BSSE MEMBERS IN 2nd QUARTER OF THE YEAR 2026

In the 2nd quarter of 2026, the total turnover of transactions on BSSE amounted to 135.847 million EUR, (by 6.29% more than in the same period last year). A total 3,110 of transactions were closed in the said period. The turnover of share transactions amounted to 1.720 million EUR (1.27 % of the total turnover) in 394 transactions, whereas the turnover of bond transactions amounted to 134.127 million EUR (98.73% of the total turnover) in 2,716 transactions.

The following tables shows the sequence of the top 5 members according to their turnovers achieved in the 2nd quarter of 2026 as divided by shares, bonds and total turnover.
